Information to Authors

SID POLICY

The Society for Information Display (SID) distributes its technical publications throughout the world. When a paper is submitted for publication by SID, it is implicit that in accepting it for publication, SID acquires the right to perform certain actions with respect to the paper. These actions may include, but are not limited to, abstraction and translation.

In connection with its publishing activities, it is SID policy to own the copyright of its technical publications in order to protect the interests of the SID, its authors and their employers, and at the same time to facilitate the appropriate re-use of its material by others.

United States copyright law requires that the transfer of copyrights of each contribution offered by an author to SID be confirmed in writing. It is therefore necessary that you complete either Part A (Copyright Transfer Form) or Part B (U.S. Government Employee Certification) and return it to the person indicated on the submission form with your submission.

AUTHOR/EMPLOYER RIGHTS

If you are an employee and you prepared your submission as a part of your job, the rights to your paper rest initially with your employer. In this case SID understands that, when you sign the copyright transfer form, you are authorized to do so by your employer and that your employer has consents to all of the terms and conditions of this form. If you are not so authorized, the form should be signed by a representative of your employer who is so authorized.

RETURNED RIGHTS: Just as the SID requires copyright to be transferred to it so that it is free to conduct its normal business, so it is the intent of this agreement to return rights to the author and employer to grant them similar freedom. JOINT AUTHORSHIP

For jointly authored papers, only one signature is required, but SID assumes that all authors have been advised of and have consented to the terms of this agreement.

U.S. GOVERNMENT EMPLOYEES

Authors who are U.S. Government employees are not required to sign the Copyright Transfer form (Part A), but any co-authors who are not U.S. Government employees are required to sign it.

Part B of the form is to be used instead of Part A only if all authors are U.S. Government employees and prepared the submission as part of their job responsibilities.

U.S. GOVERNMENT CONTRACT WORK: Authors whose work was performed under a U.S. Government contract but who are not U.S. Government employees are required to sign Part A. However, item 5 of the form returns reproduction rights to the U.S. Government when so required, even though SID copyright policy remains in effect with respect to re-use of the material by the general public.:esl.
